# Proposed Bridge Replacement on Oak Park Road (S-103) over Tools Fork Creek

# **PUBLIC INFORMATION MEETING**

### Public Meeting:

The South Carolina Department of Transportation (SCDOT) has scheduled a Public Information Meeting on Tuesday August 30, 2022, from 5pm-7pm at the Emmett Scott Recreation Center. This meeting will be held at 801 Crawford Road, Rock Hill, SC 29730. SCDOT proposes to replace a bridge on Oak Park Road (S-103) over Tools Fork Creek in York County with a structure that meets current safety standards. This meeting will have a drop-in style format with project displays available for viewing, comment forms, and informational handouts. Interested persons may attend this informal meeting at any time between 5:00 p.m. and 7:00 p.m., during which SCDOT representatives will be available to answer questions. A formal presentation will not be provided, nor will formal verbal comments be taken at this time. Attendees are encouraged to ask questions and provide written comments regarding the proposed improvements.

### Purpose/Project Overview:

The purpose of this meeting is to provide the public with an opportunity to review materials and individually discuss the project with representatives from SCDOT. Another purpose is to gather local knowledge from the public or any interested organizations regarding historic or cultural resources in the area.

The existing two-lane bridge over Tools Fork Creek would be replaced with a new bridge of similar size. A temporary detour would be provided for approximately 18 to 24 months. Eastbound motorists would travel north on Falls Road (S-102) to McConnells Highway (S-322). Westbound motorists would travel north on Oak Park Road to McConnells Highway. The detour is approximately 2.7 miles in length.
