

Welcome to the Public Information Meeting hosted by the South Carolina Department of Transportation (SCDOT) for the proposed safety project at the intersection of SC 389 and SC 394 in Orangeburg County.

SCDOT staff or their representatives are available to address any questions or concerns that you may have regarding the project. There will not be a formal presentation.



PROJECT PURPOSE

The purpose of this project is to reduce crashes through the installation of a single lane modern roundabout. In South Carolina, total crashes are reduced by 66% and injury and fatal crashes are reduced by 79% and 100%, respectively, with the installation of roundabouts at high-crash intersections.

We appreciate your time at this meeting; your attendance and feedback are very important components of the project development process.


SC 389 (JOHN NUNN HWY) AT SC 394 (SALLEY RD) INTERSECTION IMPROVEMENT PROJECT - P041026

PROJECT DESCRIPTION

The project proposed by the South Carolina Department of Transportation will convert the current intersection of SC 389 (John Nunn Highway/Ninety 6 Road) & SC 394 (Salley Road) to a roundabout. The roundabout design reduces the total number and overall severity of vehicle-to-vehicle conflict points. Comparing a conventional four-leg intersection to an equivalent roundabout design, the total number of conflict points is reduced from 32 to 8 — a 75% percent reduction. This intersection was selected for improvement through the Highway Safety Improvement Program (HSIP). This program uses a data-driven strategic approach to

identify locations throughout the state with high crash rates or patterns and implements safety enhancements through infrastructure-related improvements. The HSIP project selection requires an engineering study that includes an analysis of the crash data, an assessment of the field conditions, and an evaluation of the effectiveness of all potential countermeasure to ensure maximum safety benefits are obtained for the amount of funds invested.

ANTICIPATED SCHEDULE

Right-of-Way Acquisition: Fall 2024
Construction Begins: Fall 2025

TITLE VI COMPLIANCE: DOT under Title VI of the Civil Rights Act of 1964, as amended.
